

Export Credit / Direct Lending Knowledge Exchange & Discussion Forum

A one-day joint meeting between direct-lending eximbanks and insurers of export credit, hosted by the Berne Union and taking place on Monday 8th April, in Singapore, immediately prior to the 2019 Berne Union Spring General Meeting.

Rationale & Objectives

The purpose of the meeting is to create a platform for engagement on issues of mutual interest between the different providers of export credits. The overarching objective of the meeting is to develop a more complete understanding of the export credit landscape and facilitate a mutuallybeneficial exchange of knowledge between Berne Union Members, and counterparts from the eximbank community. As an association of providers of export credit and investment insurance cover, we are interested in engaging with our counterparts on the financing side with whom we partner routinely on business transactions to develop a better understanding of the complete export credit landscape.

The meeting will provide an opportunity for all participants to:

- meet and learn more about each others' programs and current activity levels
- understand differing mandates, roles and strategic objectives
- discuss opportunities for partnerships (e.g. complementarity of debt and equity financing)
- exchange expertise on technical matters and share views on common challenges

Format, Agenda & Participants

The format of the meeting will be a participatory roundtable discussion, including both broad strategic overview and detailed technical exchanges, explored through case studies.

Participants will include Berne Union Members (Export Credit Insurance Agencies, Private Political Risk Insurers and Multilateral institutions), as well as invited guests from Direct Lending Eximbanks, including members of the Asian Eximbank Forum (AEBF) and GNEXID.

Participants in Berne Union meetings include a mix of Senior Executives (C-Level), International Relations and technical specialists: Underwriters, Claims Specialists etc.

Since the meeting will cover both strategic and technical topics, we are encouraging participants to also send both senior managers and practitioners. The morning sessions will focus on strategic issues, and the afternoon on tackling technical issues through exploration of case studies.

In advance of the meeting each institution will be invited to submit answers to a very brief survey on their business, which will help all participants to understand the business of all institutions attending.
